- S.2 Introduction Relevance

In order to monitor the availability of grain crops in the Republic of Kazakhstan, on the initiative of the Government of the Republic of Kazakhstan, since 2008, the Committee on Statistics of the Republic of Kazakhstan has been conducting a nationwide statistical observation according to the statistical form 2-xx (grain) "On the availability of grain". This statistical observation relates to the agricultural sector.

Statistical information on the availability of cereals and legumes in the Republic of Kazakhstan is formed monthly by types of cereals and legumes and by types of their use, in the context of regions and by types of activity, and is published in express information. The source of information on the availability of cereals and legumes is the primary statistical data of legal entities and (or) their structural and separate subdivisions, peasant or farms, individual entrepreneurs engaged in the cultivation, processing, trade, storage and use of cereals and legumes.

The main indicators are:

- obtained from a new crop.
- availability of cereals and legumes at the end of the reporting period;
- including by type of use: food, seed, fodder.

The main users are the Government of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, as well as other government bodies, international organizations (FAO), business environment, media, research institutions and a number of other users.

Feedback from users is carried out through the blog of the Minister of National Economy of the Republic of Kazakhstan on the website of the Ministry of National Economy of the Republic of Kazakhstan (www.economy.gov.kz), as well as through official requests, e-mail or phone.

In addition, every year the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan holds meetings of working groups (focus groups) with the participation of potential users and respondents, representatives of interested government agencies, as well as the National Chamber of Entrepreneurs " Atameken ", which assess the indicators of national statistical observations for their relevance and the presence of duplication with indicators of departmental statistical forms and forms of administrative sources.

Express information is generated 12 times a year, of which from January to November - on a monthly basis and for December - on an annual basis. The data is generated in kind (in tons).

The output information contains data on the availability of grain and leguminous crops: by types of crops and by types of grain use (food, seed and fodder) in the country as a whole, on the availability of grain and leguminous crops by types of activity in the country as a whole and in the context of regions, cities of republican significance and the capital.

## S.4.3 Sectoral coverage

Legal entities and (or) their structural and separate subdivisions, peasant or farms, individual entrepreneurs engaged in the cultivation, processing, trade, storage and use of grain and legumes are surveyed by a continuous method.

## S.4.4 Statistical concepts and definitions

- 1. The type of observation is continuous.
- 2. Data collection toolkit is a statistical form of national statistical observation "On the availability of grain" (index 2-x, monthly frequency), which is available on the Internet resource Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan www .stat.gov.kz in the section "For respondents" / Statistical forms for 2019 / Monthly forms.
- 3. The circle of respondents: legal entities and (or) their structural and separate divisions, peasant or farm enterprises, individual entrepreneurs engaged in the cultivation, processing, trade, storage and use of grain and legumes
- 4. Deadline for submission up to 3 days (inclusive) after the reporting period, except for 3 January.
- 5. The last revision of the form is 2017.

For the convenience of filling in the data by the respondents, the following basic definitions are given in the instructions for the statistical form:

- 1) food grain grain used for food purposes;
- 2) grain the fruits of cereals, legumes and oilseeds used for food, seed, fodder and technical purposes;
- 3) granary (elevator, grain receiving point) a specialized technical facility for storing grain;
- 4) grain receipt a warehouse certificate in the form of a non-documentary non-issue security, confirming the ownership of a certain amount of grain;
- 5) feed grain grain intended for feed to animals and poultry;
- 6) seed grain (seeds) grain used for sowing purposes and divided according to varietal and sowing qualities;
- 7) weight after completion (test weight) the physical weight obtained after cleaning and drying the crop, that is, with a discount on the degree of moisture and weediness.

The statistical object is all legal entities and (or) their structural and separate subdivisions, peasant or farm enterprises, individual entrepreneurs engaged in the cultivation, processing, trade, storage and use of cereals and legumes.

The time spent on processing the first results, from the time the respondents provided to the first publication of data on the availability of cereals and legumes, averaged 10 days. The collection of data is carried out electronically on-line, and at the request of the respondent, the data can also be presented on paper. In 2018, the number of respondents who reported was 59,225, of which 40.5% of respondents provided data online by means of an EDS.

When entering data, respondents are provided with automated arithmetic and logical controls, excluding the possibility of typical input errors.

Data processing processes are automated using software systems, which provide for the control of input and output information.

The time spent on filling out the statistical form is on average up to 1 hour.

There is no duplication with other national statistical surveys. Administrative or other data sources are not used when generating express statistical information.

Primary statistical data of the statistical form of the nationwide statistical observation "On the availability of grain" (index 2-cx (grain), monthly frequency). The accounting is for food, seed and feed grain (in weight after processing), which is stored by the respondent at the end of the reporting month, and which the respondent received from the new harvest in the reporting month.

In the absence of activity during the reporting period (month, quarter, year), the respondent no later than the end date of the earliest of the deadlines for submission of statistical forms for this reporting period, specified in the Schedule for the submission of primary statistical data by respondents on national statistical observations, approved in the manner prescribed by the Law for the corresponding the year submits to the relevant state statistics body, instead of the corresponding statistical forms, the Notification of the lack of activity.

Data collection is carried out on paper or in electronic form by filling out the statistical form 2-cx "On the presence of grain". It is carried out electronically through the use of the "Online Data Collection" information system posted on the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan (https://cabinet.stat.gov.kz/).

The reliability of the data is confirmed by primary reports, which are certified on paper by seals and signatures of top managers, and submitted in electronic form - by an electronic digital signature. On the part of the Committee, the quality of data is ensured by the use of arithmetic and logical control methods when checking primary reports. In case of revealing extreme values and sharp deviations, the respondent either confirms the data that raise doubts among the statistics authorities, or makes corrections in accordance with the procedure established by law.
