S.2 Introduction - Relevance

The nationwide statistical observation on forestry in the Republic of Kazakhstan was organized with the aim of forming the main indicators characterizing activities in forestry and logging in the Republic of Kazakhstan.

On an annual basis, data are generated on forestry and logging in the Republic of Kazakhstan (in the context of regions, by types of harvested wood, by types of services provided).

Key indicators of forestry statistics:

Harvesting of untreated timber and non-woody wild forestry products;

The volume of services rendered in the field of logging;

Harvesting of timber from intermediate felling and other felling;

Harvesting of seeds of forest trees;

The volume of services rendered by tree nurseries;

The volume of services rendered in the field of forestry;

Forest management area and costs.

The main users are the Government of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, as well as other government bodies, international organizations (FAO), business environment, media, research institutions and a number of other users. Feedback from users is carried out through the blog of the Minister of National Economy of the Republic of Kazakhstan on the website of the Ministry of National Economy of the Republic of Kazakhstan.

S.4.4 Statistical concepts and definitions

- 1. The type of observation is continuous.
- 2. The circle of respondents: legal entities and (or) their structural and separate subdivisions, with the main or secondary activities according to the codes of the General Classifier of Economic Activities 02 "Forestry and logging", 01.3 "Production of nursery products" and individual entrepreneurs in the presence of a logging ticket. Submission deadline is February 21 (inclusive) after the reporting period.

3 . Data collection toolkit is a statistical form of national statistical observation "Report on forestry and logging activities" (code 141112005, index 1-forest, annual frequency), which is available on the website of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan www.stat.gov.kz in the section "For respondents" / Forms for 2019 / Annual.

Definitions:

- final felling felling of mature and over-mature stands for timber harvesting;
- Intermediate felling thinning of forest maintenance, selective sanitary felling and felling associated with the reconstruction of low-value forest plantations, as well as plantations losing protective, water protection and other functions, felling of single trees in young stands;
- sanitary felling felling (selective, clear), carried out in order to improve the sanitary state of the forest, in which sick, damaged, dying and dead trees are cut down;
- forest management a system of measures aimed at improving the efficiency of forest management, implementing a unified scientific and technical policy in forestry, ensuring the rational use of forest resources:
- forest seed plantation an artificially created plantation of plants planted according to a special genetic scheme, which are seed or vegetative offspring of plus trees, intended for the regular production (for a long time) of varietal, elite or hybrid seeds with specified hereditary properties and high sowing qualities.

The statistical object is all legal entities and (or) their structural and separate subdivisions with activities in forestry and logging and individual entrepreneurs with a logging ticket.

Legal entities and (or) their structural and separate subdivisions with primary and secondary activities according to OKED codes 02 - "Forestry and logging", 01.3 - "Production of nursery products" and individual entrepreneurs with a logging ticket are covered in full during statistical observation.
