Employed households participating in a sample household employment survey are subject to observation.

S.4.4 Statistical concepts and definitions

Household - an economic entity consisting of one or more individuals living together, pooling all or part of their income and property and jointly consuming goods and services. The survey involved 59,134 households. Observation type - selective. The interviewer interviews employed household members on the T-004 form in the months of the 3rd quarter (July, August, September). Submission deadline - July 16, August 20, September 17. Publication of information according to the plan of statistical work in February next year. Decent Work Form

T004 "was developed according to the methodology" Methodology for sampling households for the survey of population employment. "The form was revised and registered by order of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan and is available on the official website of the Committee www.stat gov.kz

#### Household

S.4.6 General population (principle of selection of survey units)

In each household, all of its members who have reached the age of 15 are interviewed. A household can consist of one person, i.e. a person living in a separate dwelling or part of it and providing himself with everything necessary for housing, as well as several persons living together and running a common household, fully or partially combining and spending their funds. These persons may be related by kinship or relations arising from marriage, or be not related, or both. The survey takes into account persons who permanently (usually) reside, including those who were temporarily absent during the survey period. Permanent place of residence is the settlement, house, apartment where the respondent spends most of his time. This place may or may not coincide with his legal permanent residence according to the registration (registration). Information is not collected on persons who are absent for a long time, regardless of the fact that they are considered to be members of the given household and this address is their main place of residence. These include:

- students and pupils of all educational institutions living at the place of study;

- those on a business trip in other settlements or abroad for six months or more before the surveyed week;

- conscripts in the Armed Forces living in barracks and military zones;

- undergoing treatment in hospitals (six months or more);

- those sentenced to a sentence of imprisonment and serving a sentence in institutions of the penitentiary system;

- others dropped out six months or more before the surveyed week.

The completeness of the data is ensured by observing the methodological recommendations according to the "Methodology for constructing a sample of households for the survey of employment of the population, approved by the order of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan dated June 30, 2016 No. 132." and instructions for filling out the statistical form of the nationwide statistical observation "Decent Labor" (index T-004, frequency three times a year) approved by the Order of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan dated February 5, 2020 No. 17.

In conditions of shortage of responses from the selected households, the missing data is compensated. This procedure is designed to carry out an additional calculation of indicators, to compensate for the shortage of data from a sample survey.

S.15.2 Sample errors - indicators / A1.

According to the Methodology for constructing a sample of households for the survey of population employment, approved by order of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan dated June 30, 2016 No. 132 when determining the size of the sample for the current year for the sample Employment Survey uses the calculation of the relative sampling error of the results of a sample survey of employment for the previous year.

The relative sampling error is calculated annually and published in the bulletin "Statistical indicators of measuring decent work in the Republic of Kazakhstan".

## S.15.3 Non-sampling error S.15.3.1

Coverage error

In conditions of shortage of selected households, the addresses of residential premises from the reserve list are replaced.

The interviewer interviews household members living at the addresses only according to the lists presented in the sample.

According to the results of the 2019 survey, the relative standard error of assessing the results of the employment survey is 0.002%

Data under-availability occurs when the sample does not participate in the survey at all. To compensate for cases of complete nonreceipt of data, a simple weights correction scheme is applied. In order to obtain data that are generalized to the general population, statistical weighting of the survey results is performed.

Weighing the results of a sample survey is carried out by assigning an appropriate weight to each individual observation unit - a person.

In the methodology for constructing a sample of households for the survey of population employment, concepts are used in the meanings defined in the Law of the Republic of Kazakhstan dated March 19, 2010 "On state statistics", dated April 6, 2016 "On employment of the population", as well as definitions adopted by the International Conferences of Labor Statisticians (hereinafter - ICLS) and recommendations of the International Labor Organization (hereinafter - ILO).

S.18.2 Internal consistency

The data of the RHS (register of housing stock) and the population size are used.

S.19 Load

Data collection is carried out on paper. Information processing processes are automated using local software systems, control of input and output information is provided.

By timing, it was found that it takes about 10-15 minutes to conduct a questionnaire survey of 1 household member. The average family ratio according to the household living standards survey is 4 people. Thus, the average amount of time spent on filling out one Questionnaire is 40-45 minutes.

Questionnaire T004 Decent Work is reviewed on an annual basis in order to bring it in line with the legislation of the Republic of Kazakhstan.

The last revision of the form was in 2019, the statistical form was posted on the Internet resource Bureau of national st ati stics of the Agency for strategic planni ng and reforms of the Republ ic of Kazakhstan (www.stat.gov.kz) in the section for respondents - Statistical forms for 2020.

The dataset is based on a questionnaire survey (survey) of households. The information system "Statistical register of housing stock", a component of the integrated information system "e-Statistics" (hereinafter - SRHS)

The specified database has a number of advantages:

availability of a ready-made sampling frame;

availability of a constantly updated database;

availability of information on households in a territorial context.

All dwelling houses and dwellings located on the territory of Kazakhstan are the accounting units of the SRLF. These include apartments, one-family (individual) houses, two-family houses, three or more apartment buildings.

The SRLF database consists of two tables, the house is the main table, contains information on the whole dwelling house, the apartment is an additional table, contains information about each apartment of the dwelling house.

Features of the formation of the general population:

the general population includes all types of residential premises, with the exception of common communal apartments, dormitories, boarding houses for the elderly and disabled, orphanages, prisons, hotels, religious communities and other similar residential premises;

in order to reduce the burden on interviewers when collecting information from the general population, settlements with a population of less than 100 households are excluded.

The dataset is based on a survey of households. Data collection is carried out on paper by filling out the statistical form T004 Decent Work Questionnaire.

- checking the conformity of the coverage of the general population;
- comparison of statistical processes with previous cycles;
- comparison of statistical data with other relevant data.
