S.2 Introduction-Relevance

In order to form, on an annual basis, the main statistical indicators characterizing the development of the animal husbandry industry in the Republic of Kazakhstan, a statistical observation was organized on the state of animal husbandry in the Republic of Kazakhstan in the context of regions, types of livestock products, categories of farms and types of livestock and poultry.

The main generated indicators of livestock statistics:

The presence and movement of livestock and poultry in the context of the Statistical Directory of Products (Services) in Agriculture, Forestry and Fisheries (SKPSH), the volume of slaughter or sale for slaughter of livestock and poultry, the number of caged fur-bearing animals, the number of bee colonies, the average number of certain types of livestock and poultry from which livestock products were obtained.

Data on livestock production are used to calculate the aggregate value indicator in agricultural statistics "Gross output of products (services) in agriculture, forestry and fisheries" for the purposes of the System of National Accounts.

The main users are the Government of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, as well as other state bodies, international organizations, business environment, mass media, research institutes and a number of other users.

Feedback from users is carried out through the blog of the Minister of National Economy of the Republic of Kazakhstan on the website of the Ministry of National Economy of the Republic of Kazakhstan.

In addition, every year the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan holds meetings of working groups (focus groups) with the participation of potential users and respondents, representatives of interested government agencies, as well as the National Chamber of Entrepreneurs " Atameken ", which assess the indicators of national statistical observations for their relevance and the presence of duplication with indicators of departmental statistical forms and forms of administrative sources.

- individual entrepreneurs, peasant or farm enterprises and households with livestock and poultry included in the sample.

Populations for livestock surveys are based on the Statistical Agricultural Register. When conducting statistical observations of agricultural production and the activities of agricultural formations, agricultural producers are fully covered.

Data collection for all legal entities and (or) their structural and separate divisions, individual entrepreneurs and peasant or farm enterprises with more than 100 employees is carried out electronically online (for 2019, 81.9% of the respondents submitted data online mode, by means of an EDS), also, at the request of the respondent, data can be presented on paper.

The collection of data on individual entrepreneurs, peasant or farm enterprises and households of the population that have livestock and poultry included in the sample is carried out by bypass methods by interviewers and, at the request of the respondents, in electronic form online (for 2019, 9.7% of the respondents who reported submitted data online, via EDS).

When entering data, respondents are provided with automated arithmetic and logical controls, excluding the possibility of typical input errors. Data processing processes are automated using software systems, which provide for the control of input and output information.

The time spent on filling out the statistical form is 1-2 hours.

There is no duplication with other nationwide surveys.

When compiling the statistical bulletin, administrative sources of data on the livestock and poultry population are used.

S.21.1 Input data

Primary data on national statistical observations in the form 24-cx "Report on the state of animal husbandry", in the form A-008 "Production of livestock products in small peasant or private farms and households", in the form 6-zh (farmer) "Information on availability livestock and poultry, agricultural machinery and buildings in peasant or farms "and in the form 7-zh (population)" Information on the availability of livestock and poultry, agricultural machinery and buildings in households. " Also, the data set is based on a questionnaire survey (survey) of small peasant or private farms and households of the population. For this survey, the general population is formed from the Agricultural Statistical Register by the method of random sampling, containing data on small individual entrepreneurs, peasant or farms and households with livestock and poultry. At the same time, individual entrepreneurs and peasant or farm enterprises with more than 100 employees are excluded from the Agricultural Statistical Register for individual entrepreneurs and peasant or farm enterprises.

The sample size for small individual entrepreneurs and peasant or farms is 30%, for households of the population - 2.5% of the general population.

S.21.3 Method (method) of collecting primary statistical data

Data collection is carried out on paper or in electronic form by filling in the statistical form 24-xx "Report on the state of animal husbandry" by the respondents. It is carried out in electronic form through the use of the information system "On-line data collection" posted on the Internet resource Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan (https://cabinet.stat.gov .kz /), according to Form A-008 "Production of livestock products in small peasant or farm enterprises and households" is filled in by interviewers from the words of an individual entrepreneur or the head of a peasant or farm enterprise or household. At the request of the owner of livestock and (or) poultry, the statistical form is filled in by himself.

Household accounting is carried out by the akims of the village, rural district through a complete bypass of yards and a survey of the population, as well as heads of peasant or farm enterprises, and twice a year information on the livestock and poultry population is provided to the Committee.

The reliability of the data is confirmed by primary reports, which are certified on paper by seals and signatures of top managers, and submitted in electronic form - by an electronic digital signature.

On the part of the Committee, the quality of data is ensured by the use of arithmetic and logical control methods when checking primary reports. In case of revealing extreme values and sharp deviations, the respondent either confirms the data that raise doubts among the statistics authorities, or makes corrections in accordance with the procedure established by law.
