S.2 Introduction-Relevance

In the field of economic statistics in Kazakhstan, the statistical business register occupies a central place. The Statistical Business Register (hereinafter - SBR) is an integral part of the official statistics of Kazakhstan. Its legal status is determined by the Law of the Republic of Kazakhstan "On State Statistics". SBR is recognized as the most effective tool for organizing and coordinating statistical observations. In terms of content, the RBU database is a specially organized and systematized list of economic entities: legal entities, their separate subdivisions and individual entrepreneurship entities. The task of creating the Register was determined by the first Program of reforming official statistics for 1993-1996, in accordance with which in 1994 the State Register of Economic and Other Entities of the Republic of Kazakhstan (SRHS) was created. After the creation of the State Register of Legal Entities in the Ministry of Justice, during the implementation of the second Program for the Improvement of State Statistics for 1996-1998, the GRHS was transformed into the Administrative Register, and then in 1997 into the State Statistical Register (Statistical Business Register). The structure and content of the SBR are determined by international standards and recommendations in the field of business statistics. Statistical form 1-CP is intended for updating the SBR (in terms of the type of economic activity, the number of employees and contact details).

S.4 Presentation of statistical information

S.4.1 Data description

Statistical Form 1-CP is intended for updating the SBR (in terms of the type of economic activity, the number of employees and contact details). Also, on the basis of the statistical form 1-CP, the bulletin "Main indicators of the number of legal entities, individual entrepreneurship, branches and branches of foreign legal entities in the Republic of Kazakhstan" is formed and published.

To date, the SBR is formed on the basis of electronic notifications coming from the State Database "Legal Entities" of the Ministry of Justice of the Republic of Kazakhstan (hereinafter - SDB LE, as well as information coming from the information system of the State Revenue Committee of the Ministry of Finance of the Republic of Kazakhstan (hereinafter - SRC MF RK).

SDB LE receives information about newly registered legal entities, branches, representative offices and individual entrepreneurship entities in the form of joint venture (JV) in the territory of the Republic of Kazakhstan (hereinafter - RK), as well as information on changes (change of the head, owners, name, address and etc.).

Information about registered and deregistered individual entrepreneurs carrying out activities in the form of personal entrepreneurship (IE) comes from SRC MF RK.

S.4.2 Classification system

OKED is a general classifier of types of economic activities in accordance with the Nomenclature of Types of Economic Activities (OKED 5-digit)

S.4.3 Sectoral coverage

They are represented by legal entities engaged in entrepreneurial activities with a number of employees of no more than 100 people, with the exception of those who submitted the statistical form "Report on the activities of a small enterprise" 2-MP in the 1-3 quarter of the current year, as well as those registered in the reporting period.

S.4.4 Statistical concepts and definitions

The annual update of the SBR is carried out by employees of the responsible department for maintaining registers of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan, on the basis of annual statistical forms.

According to the annual statistical forms, a separate file is formed for updating the SBR, in which information on secondary activities and economic indicators from statistical forms are entered for each reporting unit:

"Report on labor" (1-T);

"Report on the activities of a small enterprise" (2-MP)

"Report on the financial and economic activities of the enterprise" (1-PF)

"Report of an enterprise providing services in the field of trade, catering and repair of vehicles" (1-BT)

"Report on the volume of services rendered" (2-services)

"Report on the types of economic activities" (1-CP)

The information from the file is analyzed and compared with the data from the SBR, the conflicting information is corrected or deleted.

On the basis of the worked out information, the SBR is updated by the employees of the responsible department for maintaining registers of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan together with the departments of registers of the DS.

Definitions:

- 1) the main type of activity of an enterprise - a type of activity, the added value of which exceeds the added value of any other type of activity carried out by the entity;
- 2) secondary type of activity - a type of activity, in addition to the main one, which is carried out for the purpose of producing products for third parties.

The bulletin includes indicators from the Statistical Business Register, which contains lists of legal entities, branches and representative offices that have registered or re-registered in MJ RK and individual entrepreneurs that have been registered or re-registered with SRC MF RK.

As of January 1, 2000, 120,910 legal entities were registered in the Republic of Kazakhstan (including by forms of ownership: state 22,254, private 96,263, foreign 2,393).

As of January 1, 2019, 433,774 legal entities were registered (including by forms of ownership: state 26,483, private 381,972, foreign 25,319).

During this period, the number of registered legal entities increased by 3.5 times or by 312,864 legal entities (including by forms of ownership: state-owned increased by 0.1% or by 4,229 legal entities, private - by 4.5 times or by 285 709, foreign - 10.5 times or 22 926).

The submission of this statistical form is carried out on paper or electronically. Filling in the statistical form electronically is carried out through the online data collection information system posted on the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan (<https://cabinet.stat.gov.kz/>).

One of the important tasks of the statistical business register is updating based on data from administrative sources. The SBR allows you to attract data from administrative sources, which can be useful for updating information on legal (statistical) units and their classification attributes contained in the SBR.
