S.2 Introduction-Relevance

The nationwide statistical observation on the gross harvest of agricultural crops in the Republic of Kazakhstan is organized with the aim of forming the main indicators characterizing agricultural activity in the Republic of Kazakhstan. On an annual basis, agriculture statistics form data on the gross harvest of agricultural crops in the Republic of Kazakhstan (in the context of regions, by crops, by categories of farms). Indicators on the gross harvest of agricultural crops are the primary statistical data of national statistical observation, which is formed according to the "Methodology for organizing and conducting a survey of the yield of grain crops", approved by the Order of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan from November 27, 2017 No. 187 and "Methodology for conducting sample surveys in crop and livestock production", approved by the Order of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan dated November 10, 2017 No. 164.

Main indicators of agricultural statistics: The area of the dead crops of spring crops, Adjusted cultivated area, Gross harvest of agricultural crops, Gross harvest of flowers in open ground, Gross harvest of certain types of crop production,

Perennial planting area,

The area of perennial plantings at a fruiting age,

Gross harvest from the area of perennial plantations at a fruiting age,

About the harvesting of agricultural crops in protected soil (the used area of greenhouses, in square meters and the gross harvest, in centners),

Gross harvest of flowers in protected ground,

Gross harvest of organic crop production,

On the introduction and use of fertilizers (mineral, in kg (nitrogen, phosphorus, potash) and organic, in tons);

About the fertilized area of agricultural crops;

On the use of moisture-saving technologies in the cultivation of grain crops.

Considering that agricultural statistics plays an important role in the development of the state's economy, the main users of official statistical information are the Government of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, as well as other state bodies, international organizations, business environment, media, research institutes and a number of other users.

S.4.3 Sectoral coverage

In the Republic of Kazakhstan, the cultivation of various types of agricultural crops is carried out by agricultural enterprises (hereinafter referred to as agricultural enterprises), individual entrepreneurs and peasants or farms, households (producing products on personal and summer cottages).

At the same time, grain crops, in particular wheat and rice, are grown mainly by agricultural enterprises, individual entrepreneurs and peasant or farm enterprises, in connection with which these categories of agricultural producers have been identified as objects for examining the yield of grain crops.

S.4.4 Statistical concepts and definitions

- 1. The type of observation is continuous.
- 2. The circle of respondents: legal entities and (or) their structural and separate subdivisions, with the main or secondary activities according to the codes of the General Classifier of Economic Activities 01.1 "Growing seasonal crops", 01.2 "Growing perennial crops", 01.3 "Production of nursery products" and 01.5 "Mixed farming"; individual entrepreneurs and peasant or farms with more than 100 employees. Submission deadline November 2 (inclusive) of the reporting period.
- 3. Data collection toolkit is a statistical form of national statistical observation "On the harvesting of agricultural crops" (code 141112203, index 29-cx, annual frequency) (hereinafter referred to as the statistical form). The statistical form is available on the website of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan www.stat.gov.kz in the section "For respondents".

S.4.5 Statistical object

The statistical object is all legal entities and (or) their structural and separate subdivisions, individual entrepreneurs and peasant or farms with more than 100 employees.

S.4.6 General population (principle of selection of survey units)

Populations for surveys in crop production are based on the Agricultural Statistical Register. Agricultural producers are fully covered when conducting statistical observations of crops and the activities of agricultural formations.

Data collection is carried out on paper or in electronic form by filling out the statistical form 29-cx "On the harvesting of agricultural crops". In electronic form, it is carried out through the use of the information system "Data collection in on-line mode" posted on the Internet resource Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan (www.stat.gov.kz).
