S.2 Introduction-Relevance

National statistical observation on the results of sowing for the harvest, which characterizes the sowing of agricultural crops in the Republic of Kazakhstan.

On an annual basis, agricultural statistics form data on the results of sowing agricultural crops in the Republic of Kazakhstan (in the context of regions, by crops and categories of farms).

Considering that agricultural statistics plays an important role in the development of the state's economy, the main users of official statistical information are the Government of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, as well as other state bodies, international organizations, business environment, media, research institutes and a number of other users.

- S.4 Presentation of statistical information
- S.4.1 Data description

The main indicators are the area of winter crops sown from last fall, the area of insured crops of winter crops, the area of winter crops preserved for grain by the end of the sowing of spring crops, the area of winter crops used for green fodder and grazing, the area of spring crops, the insured of spring crops, the area of spring crops in the aisles of orchards, the area of preliminary crops on plowed hayfields and pastures, the cut area of perennial grasses of past years, the area of undercover perennial grasses (overseeding, including overseeding from autumn).

The circle of respondents: according to the 4-cx (year) form, legal entities and (or) their structural and separate subdivisions with primary and secondary activities according to the codes of the General Classifier of Economic Activities 01.1 "Growing of one- or two-year crops", 01.2 "Cultivation Perennial Crops ", 01.3" Plant Reproduction "and 01.5" Mixed Agriculture "; individual entrepreneurs and peasant or farm households as well as households of the population are formed on the basis of the household book. Submission deadline - June 15 (inclusive) of the reporting period.

3. Data collection toolkit - statistical form of national statistical observation "Report on the results of sowing for the harvest" (index 4-cx, annual frequency); household book. Statistical forms are available on the website of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan www.stat.gov.kz in the section "For respondents".

Statistical objects in the form 4-cx (year) are legal entities and (or) their structural and separate divisions with primary and secondary activities according to the codes of the General Classifier of Economic Activities 01.1 "Growing of one or two-year crops", 01.2 "Growing of perennial crops", 01.3 "Reproduction of plants" and 01.5 "Mixed agriculture" as well as for individual entrepreneurs and peasant or farms, households of the population a household book (producing products on personal and summer cottages).

Official statistical information> Operational data (express information, bulletins)> Statistics of agriculture, forestry, hunting and fishing> Bulletins. The release dates were approved and published in the Statistical Work Plan and the Schedule for the Dissemination of Official Statistical Information.

In which the data on the adjusted sown areas will be reflected are reflected taking into account the actual sowing of late crops for the harvest of the current year (for example, summer planting of potatoes), taking into account the actual size of completely dead crops of winter crops, as well as taking into account the economic use of crops (for grain, hay etc).

Collection in forms 4-cx (year) and household book is carried out in electronic form and on paper. Data collection is carried out online, in which automated arithmetic and logical controls are provided for the respondent, excluding the possibility of typical input errors. Information processing processes are automated using local software systems, control of input and output information is provided. Time spent on filling out the statistical form up to 1 hour. There is no duplication with other examinations. Household ledger data is collected by employees of akimats and is administrative data.
