S.2 Introduction-Relevance

The quality report is based on a survey of the quality of life of the population, carried out once a year.

The survey on quality of life includes households living in all types of dwellings, with the exception of those living in shared communal apartments, dormitories, nursing homes for the elderly and disabled, orphanages, prisons, hotels, religious communities and other similar dwellings. This survey examines the level of satisfaction with the respondents' life, living conditions, health, financial situation, quality of housing in which they live, quality of drinking water, availability of free time, including satisfaction with government services in health care, education and other aspects of living standards.

S.4.2 Classification system

The Household Quality of Life Survey does not use any generally accepted classifications, but uses certain reference books approved by the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan.

S.4.3 Sectoral coverage

According to the purpose of the survey, the satisfaction of respondents with the following aspects of the quality of life is studied:

The respondent to the quality of life survey is one household member aged 15 and over;

- in order to improve the quality of data, check the correctness of filling out the statistical form and minimize the lack of answers on some questions of the statistical form, plausibility checks are defined at the level of inputting primary data in electronic format, various format and logical controls are also included in the software for processing primary statistical information.

In the course of the survey, there are cases when it is not possible to interview households due to the fact that the dwelling has not been found, or not occupied, or the household refuses to participate in the survey. Refusal to participate is undesirable because it reduces the sample size and mainly because it is a source of potential sample bias and leads to distorted statistical results. An effective preventative measure for overcoming data failure is to carefully document each case. If there is a difficulty in observing the principle of "nonreplacement", a list of reserve households is provided in the amount of 1/3 of the number of households in each cluster (10 households per interviewer). In total, 40 dwellings are selected in each cluster: 30 in the nominal sample and 10 replacement dwellings. At the same time, it should be noted that to compensate for cases of complete non-receipt of data, a simple weights adjustment scheme is used by setting large weights for all responding households in a given locality. The lack of data due to refusals to participate in the survey is about 5%.

Data collection is carried out on paper. In 2019, one member of 11,931 households aged 15 and over were respondents to the survey. Information processing processes are automated using local software systems, control of input and output information is provided. Duplication with other examinations is excluded. No administrative data is used.

The grounds for revising the statistical form are the recommendations of international organizations and the proposals of state bodies at the level of revising statistical tools and data processing. The statistical form was last revised in 2018, taking into account the EU-SILC questionnaires.

S.21 Processing of statistical data

S.21.1 Input data

The collection of statistical information is carried out by filling out the statistical form by the respondent independently. The respondent is a household member aged 15 and over. When filling out the Statistical Form, the respondent is guided by personal feelings (feelings) when answering the proposed questions. The level of satisfaction of the respondent is determined in accordance with the proposed scale from 1 to 10, where from 1 to 3 is dissatisfaction, from 4 to 7 - partial satisfaction and from 8 to 10 - complete satisfaction.

S.21.3 Method (method) of collecting primary statistical data

The data collection method is carried out by the interviewing method. Data collection is carried out on paper by filling in statistical forms D 008 "Control card of household composition" and D 002 "Quality of life of the population". The collection of primary statistical data is carried out in accordance with the Schedule for conducting national statistical observations by interviewers on a sample survey of households to assess the standard of living, according to the form presented in Appendix 1 to this Methodology. Data registration is performed by polling method.

The main components of the survey are: a main interview, during which the first contact with the household is established, a list of all household members is compiled and basic information is collected about the household as a whole and individual characteristics of each household member, a date for subsequent interviews is set

S.21.4 Reliability of primary statistical data

Data processing procedures include editing, importing and aggregating data. At the first stage of processing, the database is edited and brought into working condition. For this, the following types of control are carried out:

- 1) control for identifying extreme values (outlays). The area of extreme values of indicators is outside the interval, the boundaries of which are determined by the deviation from the average value of indicators by the value of the standard deviation:
- 2) the maximum and minimum values of quantitative indicators are analyzed;
- 3) assessment of the quality of the information received from the respondents. For this purpose, within each section of the questionnaire, a logical control system is built that allows you to eliminate both input errors and registration errors on the part of households: expenses that are atypical for households (purchase of exotic food or expensive food for feeding pets), residential the area should not be more than the total;
- 4) control based on the logical relationship of information obtained from different statistical forms. With the help of cross-questions, the relationship between the questionnaires is checked, the completeness of filling out forms is controlled.
